

Privacy Policy for Ripley Castle Shooting Club

Effective Date: 10th December 2024

Ripley Castle shooting Club (“we,” “our,” or “us”) is committed to protecting the privacy and confidentiality of our members, visitors, and guests. This Privacy Policy explains how we collect, use, and protect your personal information. It also outlines our strict no-photography policy to ensure the safety, privacy, and security of all individuals on our premises.

1. Information We Collect

We may collect the following types of personal information:

- Personal Identification Information: Name, address, phone number, email address, and date of birth.
- Membership Information: Membership ID, membership status, payment history, and transaction details.
- Legal and Safety Information: Firearms license details, certifications, and training records.
- Facility Usage Data: Information about your visits, participation in events, and use of facilities.

2. How We Use Your Information

We use your personal information for the following purposes:

- To process membership applications and manage your account.
- To comply with legal and regulatory requirements, such as firearm license verification.
- To communicate club updates, events, and notifications.
- To ensure the safety and security of all individuals on the premises.

3. No Photography Rule

Exceptions:

- Club-authorized photography for specific events or promotions, with prior notification and consent from participants.

We do not sell, rent, or share your personal information with third parties, except in the following situations:

- Legal Compliance: When required by law or to respond to lawful requests by government authorities.
- Service Providers: To trusted partners who assist in operational activities, such as payment processing.
- Consent: When you provide explicit consent for specific purposes.

5. Data Security

We implement strict security measures to protect your personal information against unauthorized access, disclosure, or misuse. These measures include:

- Secure storage of physical and digital records.
- Limited access to personal data by authorized personnel only.
- Regular review and updates to our security practices.

6. Data Retention
